Why choose Hospitality?





Hospitality focuses on theoretical and practical skills set over a two year period and skills will also be transferable into the work place.

Students develop an understanding of hospitality and the structure, scope and operation of related activities in the food and beverage sector and examine and evaluate industry practices from the food and beverage sector.

Students develop skills in food and beverage production and service. They work as individuals and as part of teams to plan and implement events in a hospitality context.

Events provide opportunities for students to participate in and produce food and beverage products and perform service for customers in real-world hospitality contexts.



WHAT IS FASHION?

- Fashion is a two year course which focuses on both theoretical knowledge and practical skills which are transferable into the workplace.
- Students learn to appreciate the design aesthetics of others while developing their own personal style and aesthetic. They explore contemporary and historical fashion culture; learn to identify, understand and interpret fashion trends; and examine how the needs of different markets are met.





The expectation is that students engage in both theory and practical applications in order to ready themselves for the workplace.

The Fashion course is designed around core and elective topics. The elective learning occurs through fashion contexts.

Some weeks the students will be involved in ventures whereby they produce and sell food to customers, mainly as paid functions.

The levy charged does not fully cover costs, therefore profits from ventures enables the students to participate in a wide range of practical activities.

The objectives of the venture are to enable students to apply knowledge and skills learnt in a practical situation.

COURSE OVERVIEW

- Early Childhood Studies is an APPLIED subject.
- It is a four-unit course of study.
- It contains both theory and practical components.

It is hands-on providing work placement experience in a real childcare centre.







Why choose Early Childhood Studies?

Early Childhood Studies focuses on learning about children aged from birth to five years. Students explore play-based learning activities from <u>two perspectives</u>: they use theories about early childhood learning and devise play-based learning activities responsive to children's needs. Students examine the concepts and ideas of the fundamentals and practices of early childhood learning. They plan, justify and evaluate play-based learning activities responsive to the needs of children as well as evaluating contexts in early childhood learning. This enables students to develop understanding of the multifaceted, diverse and significant nature of early childhood learning.

You will plan and implement a play-based learning activity for a children's party which incorporates healthy eating and appropriate games that promote physical activity.
